### Possession/Vacation of Stalls

- a) Possession of Stall(s) to the Exhibitors will be given on September 5, 2006 at 12 noon. The display and decoration of the Stall(s) must be completed by 09:00 hrs. on September 6, 2006, to be ready for the opening.
- b) Possession of Bare Space to companies building through their own Booth designers/contractors will be given on September 4, 2006 at 11 a.m.
- c) Exhibitors/Contractors of companies doing their own stand constructions must get their designs, layouts, height specifications approved from the organisers atleast 4 weeks before the exhibiton.
- d) Mezzanine or Extra Floor constructions entail special permission and extra costs from the ITPO and Organisers. Kindly get these approved in advance from the Organisers atleast 4 weeks before the exhibiton.
- e) The Exhibitors must vacate the Stall(s) before 10 p.m. on September 8, 2006, to enable the organisers to hand over vacant possession of the Hall to the India Trade Promotion Organisation (ITPO) authorities.
- f) The Organisers shall not be responsible for any loss of exhibits, if the same are not removed after the closer of the Exhibition.

## Exhibitor Badges

- a) Exhibitor badges will be given to the Exhibitors at the time of Exhibitors Registration on September 5, 2006 between 12 noon - 6 p.m. at the registration counter outside the Exhibition Halls.

## Exhibition Related Movements

- a) All Exhibition related material, goods to be brought in and out from Gate No. 1, Pragati Maidan only.
- b) All the equipment/material should be carted in and out of the Exhibition Hall between 8 p.m. and 8 a.m., as per municipal rules. Under no circumstances, the material will be allowed to come in/go out during 8 a.m. to 8 p.m., when Heavy Vehicles are not allowed to ply on roads.
- c) All the equipment should be carted in and out on trollies to avoid any damage to the flooring. The equipment should be directly transported to the Exhibition Hall.
- d) No painting or carpentry work will be allowed inside the Exhibition Hall. All materials should be pre-fabricated at the Exhibitor's premises and only minimal assembly work should be carried out inside the hall, and should be done under strict supervision.

## Liability and Insurance

- a) The Organiser shall make appropriate arrangements for security and safety of the exhibits by insuring them against theft/fire, etc. and arranging security guards. However, the Exhibitors are advised to arrange separate insurance cover, if they so desire.
- b) The Organisers shall not be responsible for any theft or loss whatsoever or damage to the exhibits during the Exhibition timings, when the Exhibitors are supposed to look after their exhibits by deputing their own representatives.

## IMPORT OF EXHIBITS

Foreign Exhibitors at SmartCards Expo 2006/Rfid/India Expo 2006/ IndiaMobileForum 2006/e-Security Expo 2006 are allowed to import non-consumable goods required for display in the Exhibition without paying any import duty, provided the goods in question are re-exported within a period of six months from the date of import into India, as per the information below.

### ATA CARNET:

India is a signatory to the ATA Carnet System and import of goods is governed by its rules. All Exhibitors belonging to the Member Countries of ATA Carnet will get ATA Carnet issued from their country's Chambers of Commerce or any agency authorised to issue carnet duly certified by the customs. When goods arrive in India, the temporary importation for six months will be allowed on the basis of the ATA Carnet procedure.

The following categories of items will not, however, be covered and the Exhibitors are advised to file separate bills of entry as the temporary imports will be governed by the Government of India's normal rules.

- a) All consumable goods meant for distribution or sale which are not likely to be re-exported.
- b) Goods imported through the medium of post.
- c) Transit goods.

A separate bill of entry will be required to be filled in for such consignments and import clearance will be governed by normal rules of the Government of India customs.

The temporary import of the Exhibits, goods from the countries who are not members of ATA Carnet, will be governed by the following rules:

- a) The Exhibitors will be required to produce a guarantee letter from their respective Embassies in India.
- b) If the exhibits are not guaranteed by the Embassy, some local Indian company, acceptable to the Collector of Customs, must stand guarantee before a Bank Guarantee can be waived.
- c) In case the Exhibitor cannot comply with (a) and (b) above, he will have to produce a Bank Guarantee to the tune of 250% of the invoice value of the goods, as per the customs rules.

## Guidelines for companies from Taiwan participating in SmartCards Expo 2006/RFid/India Expo 2006/IndiaMobileForum 2006/e-Security Expo 2006 Exhibition and Conference

As far as the Taiwanese participation in international events in India is concerned, the following norms must be observed:

- i) Taiwan may participate under the nomenclature of "Chinese Taipei" or "China Taipei". It may also retain its standard nomenclature in a particular international organisation if that organisation is holding its meeting in India. However, there shall be no reference to Taiwan as the "Republic of China".
- ii) There shall be no display of national flag, country nameplate, national emblem or singing of the national anthem of the so-called "Republic of China".
- iii) Taiwanese delegates shall not engage in any political activity; their participation shall not be political in nature.

The visit of individual businessman from Taiwan may be organised within the following parameters:

- i) They visit India in their individual capacity, and not as representatives of the so-called "Republic of China".
- ii) There shall be no display of national flag, country name plate, national emblem or singing of national anthem of the so-called "Republic of China" at any public event organised for or by them in India.
- iii) They shall not engage in any political activity while in India.
- iv) There shall not be any reference to the term "Republic of China" in any formal document signed during the visit.

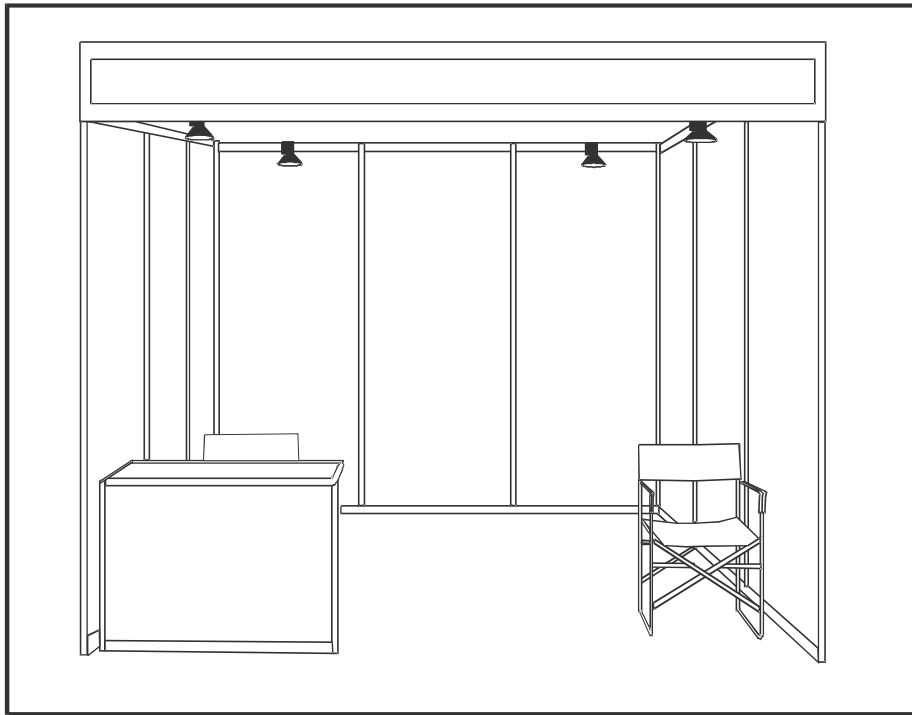

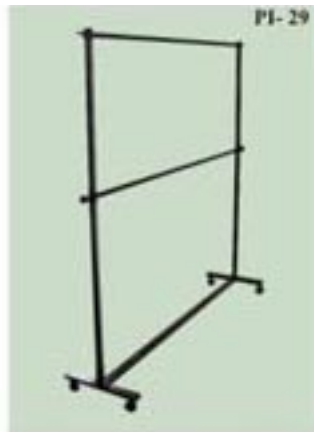

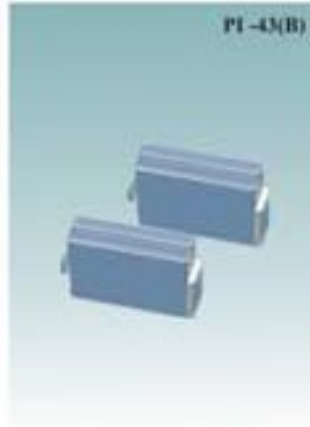
